Emerging Research Information (EmeRI) Information Policy

1 The **Emerging Research Information preprint repository (EmeRI)** is the result of a cooperation between the Brazilian Association of Scientific Editors (Abec), Brazilian Institute of Information in Science and Technology (Ibict) and United Nations Educational, Scientific and Cultural Organization (UNESCO) - Office in Brazil.

2 The EmeRI is the database used for the registration and dissemination of preprints submitted to scientific journals that previously signed an agreement with Abec.

Single paragraph. Preprints are versions of scientific articles that have not yet undergone peer review. In order for preprints to be deposited at EmeRI, they must have been submitted to scientific journals and have undergone a prior review as to grammar, spelling, content and form, thus being accepted for the formal peer review process, but have not yet been evaluated.

3 For the registration of magazines in EmeRI, the responsible editor must contact the administrators by e-mail found in the “Contact” tab of the platform and request the registration of the magazine.

4 Are prerequisites for scientific journals wishing to compose EmeRI

I - Be of academic / scientific character;

II - Have ISSN registration;

III - To be in accordance with the Distribution License formulated by EmeRI;

5 The information architecture of EmeRI follows the structure of “communities, collections and items”, defined by the software used for its construction, the DSpace.

§ 1 - The community is called Scientific journals and is managed by EmeRI administrators;

§ 2 - The collections are represented by each of the magazines that make up EmeRI and are managed by the editors themselves under the supervision of the administrators;

§ 3 - The items are represented by the preprints that will be submitted by the editors of the magazines to EmeRI and will be subject to approval by the administrators.

6 The submission of preprints to EmeRI may be carried out by any of the members of the magazine's editorial team, as long as the editor-in-chief agrees.

7 The preprint files submitted to EmeRI must follow a minimum formatting standard, according to the supplementary document available in EmeRI.

Single paragraph. The supplementary document referred to in this article contains the standard formatting that must be applied to all preprints submitted to EmeRI.

8 The preprint files submitted to EmeRI must be in PDF format.

Single paragraph. If EmeRI administrators deem it necessary to make the file available in formats other than PDF, the conversion of the file is permitted, without any change in its content.

9 It will be the responsibility of the editorial team of each journal to review the “Guidelines for authors” and show that all submissions made to the magazine may be deposited with EmeRI, without any prejudice regarding intellectual property.

Single paragraph. The analysis of research results that can be patented must be done beforehand between the author (s) and the journal, and EmeRI does not have any type of management on the issue.

10 The review, editing, validation, approval and availability of the fields of the preprint records submitted to EmeRI will be done by teams from Abec and Ibict, according to internal policies signed between the institutions.

11 All preprint registrations submitted to EmeRI will be available in open access immediately after their approval by the administrators.

12 The guarantee of full functioning, updating, development and absorption of new technologies and technical improvements will be made by teams from Abec and Ibict, according to internal policies signed between the institutions.

13 EmeRI must be able to integrate with other systems, national and international, observing the use of standards and protocols adopted worldwide.
